





The Bangsamoro Autonomy Act No. 12, Section 2, states that the Bangsamoro Government shall promote physical education and encourage sports programs. League competitions, and amateur sports, including training for regional, national, and international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry. It shall develop innovative and productive individuals, promote sportsmanship, cooperation, encourage and support indigenous games, martial arts and amateur sports. It shall further recognize the diverse cultures of the region and consider gender, culture, and religious sensitivity.

Whereas, Section 11 (c) (5) of the Bangsamoro Autonomy Act No.12, provides that, among the powers and functions of the Bangsamoro Sports Commission is to monitor, assess and ensure compliance of Bangsamoro Government agencies with the issued guidelines and implementation of their sports programs. For this purpose, the BSC may require all ministries, agencies and offices of the Bangsamoro Government to submit their sports plan and budget as well as regular reports on the status of implementation and utilization thereof.
