1. Book IV, Title II (B), Section 18 of the Bangsamoro Autonomy Act No. 13 or the "Bangsamoro Administrative Code" provides:

"Sec. 18. Legal Liaison Network. – The legal officers in the Bangsamoro Attorney – General’s Office and the legal officers in various Bangsamoro ministries, agencies, offices, or instrumentalities who carry out legal services or other legal duties, shall form and compose the Legal Liaison Network (LLN) of the Bangsamoro Government. They shall cooperate and coordinate on legal, policy, and legislative matters. The Bangsamoro Attorney – General shall be the ex – officio Chairperson of the LLN."

2. To strengthen the coordination between and among the above legal officers comprising the LLN, the heads of all ministries, offices, and agencies are hereby directed to identify and designate their respective permanent and alternate focal persons who shall be primarily responsible for maintaining smooth working relation with the LLN.
3. Kindly fill out the attached form providing the details of the focal persons and other legal officers who are performing legal duties, as defined under the Bangsamoro Administrative Code, and submit the same to the Bangsamoro Attorney General’s Office (BAGO) through bago@bangsamoro.gov.ph on or before May 19, 2023.
