**SUBJECT : NETWORK BOARD ELECTION AND APPOINTMENT OF OFFICERS OF THE**  
**LEGAL LIAISON NETWORK (LLN)**

**DATE : May 22, 2023 | Dhu'l-Qi'dah 2, 1444 AH**

1. Based on the LLN Internal Rules and Procedures (IRP), the Network Board of the LLN shall be composed of the Chairperson, three (3) officers (President, Vice-President, and Secretary), and five (5) Network Board Members. The President and Vice-President shall be elected by a majority of the LLN members while the Secretary shall be appointed by the Chairperson. The Network Board Members shall be the Heads of the Technical Working Committees (TWCs) and shall be appointed by the Chairperson along with their Assistant Heads.
2. Following the finalization of the LLN IRP in Davao City last January 24-28, 2023, there is a need to convene the members of the LLN for the purpose of electing its officers and appointing the Heads and Assistant Heads for each committee by the Chairperson.
3. The LLN officers, TWC Heads, and TWC Assistant Heads shall set the LLN's mission, purpose, direction, priorities, and strategies within the bounds of LLN's mandates. Further, they shall ensure that the LLN and its TWCs are duly organized and performing their duties in accordance with high quality assurance and standards.
4. The LLN plays a vital role in reviewing proposed Cabinet legislation, among others, in support to the Cabinet Legislative Committee.
5. The LLN's Network Board election and appointment of officers shall be on **May 29, 2023, from 9:00 AM until 12:00 PM (final venue to be announced)**, with support from Suporta sa Bangsamoro Transition.
