SUBJECT : FINAL PRESENTATION OF THE IMPLEMENTING RULES AND REGULATIONS ON ALTERNATIVE DISPUTE RESOLUTION

DATE : 04 Rabi Al-Awwal 1445 AH | 19 September 2023

1. Book V, Chapter 9 of the Bangsamoro Administrative Code mandates the Bangsamoro Attorney-General to promulgate the rules and regulations on the resolution of all disputes, claims, and controversies, between or among the ministries, offices, agencies (MOAs), bureaus, and instrumentalities of the Bangsamoro Government, including government-owned or controlled corporations (GOCCs).
2. On November 16, 2022, lawyers from the Bangsamoro Attorney-General's Office participated in the first Presentation of the proposed Implementing Rules and Regulations (IRR) on Alternative Dispute Resolution (ADR) held in Cotabato City.
3. The second presentation of the draft IRR on ADR was conducted between January 24-28, 2023, with the members of the Legal Liaison Network attending in Davao City.
4. The **Final Presentation of the IRR on ADR** is scheduled on **October 3 and 4, 2023** in **Cotabato City** (Final venue to be announced).
5. All MOAs of the Bangsamoro Government, including GOCCs operating within the Bangsamoro Autonomous Region in Muslim Mindanao, are required to send **one (1)** representative to attend the event.
