  - b. The additional responsibilities of your office based on the commitment to the sustainability of the OCM Citizen's Charter;
  - c. The recommendations in compliance with findings on the audit of OCM's implementation of the recommendations of the Commission on Audit (COA) for C.Y. 2022 (refer to Memorandum Order 0413, Series of 2023); and
  - d. The recommendations in compliance with findings on the audit of payment transactions of the OCM (refer to Memorandum Order No. 0411, Series of 2023).

4. For attached offices, and special programs with approved "Continuing Appropriations," all PAPs for January to June 2024 outlined in your WFP for Catch-Up Plan must be reflected in your office's commitment form.
