2. The committee, among others, shall perform the following functions:
- a. Inspect the unserviceable equipment and property to verify justification for disposal;
 - b. Set the final appraised value of all properties considering obsolescence, market demand, physical condition, and the result of biddings for similar property;
 - c. Recommend to the Chief Minister or his Authorized Representative for approval, the manner of disposal taking;
 - d. Conduct public bidding of the sale of all disposable property on an "AS IS, WHERE IS" basis and recommend corresponding award;
 - e. The Disposal Committee Chairperson shall call the meeting of the Committee and initiate the activities in the disposal process. In cases of conflicts or differences among the Committee members especially regarding varying appraised values, the Chairperson shall make the final decision as to which recommendation shall be submitted to the Chief Minister or his Authorized Representative for approval;
 - f. Be clothed with full authority to make decisions in behalf of their offices during the various committee deliberations; and
 - g. Perform other functions as may be assigned by the Chief Minister or by law.

This Memorandum Order shall take effect immediately and shall continue in effect unless modified by competent authority. This order supersedes all issuances, memoranda, or orders inconsistent herewith.
