- 1. The 18-Day Campaign to End VAW supports the Philippines' goal of protecting the human rights of women and girls by upholding its commitment to address all forms of gender-based violence as enshrined in the 1987 Constitution. By virtue of Republic Act 10398 or the Act declaring November 25 of every year as the National Consciousness Day for the Elimination of VAWC, government agencies are mandated to raise awareness of the problem of violence and the elimination of all forms of violence.
- 2. Relative to this, all ministries, offices, and agencies through its GAD Focal Point System are directed to submit data in relation to their respective Gender and Development (GAD) Programs with adequate data interpretation on or before 16 September 2024, at 5:00 p.m. to the Bangsamoro Women Commission. Additionally, the Commission welcomes any other significant data or highlights your office wishes to include. This is to cover all necessary updates on the latest data available for understanding the status of women in BARMM, and in preparation for the 6th State of the Bangsamoro Women Address (SoBWA) to be delivered during the kick-off of the event.


