SUBJECT : ESTABLISHMENT OF OCM PROGRAM DATABASE

1. The General Appropriations Act of Bangsamoro for the Fiscal Years 2020-2024, in compliance with the Full Disclosure Policy, provides under its General Provisions the “Principle of Transparency on Public Funds and Implementation of Infrastructure Projects” to be posted in the ministries, offices, and agencies official website.
2. Section 25 (1), Title II, Book IV of the Bangsamoro Autonomy Act No. 13, otherwise known as the *Bangsamoro Administrative Code* provides that the Technical Management Service as one of the Bangsamoro Management Support Systems of the Office of the Chief Minister is mandated to develop a system that will assess the performance of ministries, offices, and bureaus under the supervision of the Office of the Chief Minister.
3. Memorandum Order No. 363, Series of 2023, entitled “Revised Guidelines on the Submission of Monthly, Quarterly, and Annual Accomplishment Reports” provides under its submission(f) procedure that “*Special Programs and Attached Offices shall quarterly submit project or program data along with the accomplishment reports in order to track the progress of the program or project implementation.*”
4. The OCM Program Database, in compliance with the foregoing mandate and the Full Disclosure Policy requirements, is a system designed to provide accessible and credible overall progress on the state of program implementation under the Office of the Chief Minister.
5. Pursuant thereto, all special programs and attached offices are **enjoined to submit copies of the consolidated program databases of your office’s performance indicators** stipulated in the General Appropriation Act of Bangsamoro for the Fiscal Years 2020-2024 to this Office through the TMS-PMD on or before **September 15, 2024**.

6. This memorandum will also serve as a **reminder** to regularly submit the program database in compliance with the aforementioned provision of Memorandum Order No. 363, Series of 2023.
